The policy contains 14 day "Cooling Off" and you can obtain full refund of the premiums paid or alternatively upgrade and pay additional premiums as applicable. If you have any questions regarding the insurance cover, or wish to declare any medical condition(s), please telephone ABC Holiday Extras Ltd. help line direct on 0800-652 1018

The insurance does not cover you in the following circumstances:

1. If you have received inpatient or out-patient treatment in a hospital or clinic within the last six months or if you are on a waiting list to receive treatment or exploratory tests for:
 - any of these heart conditions: angina, irregular heartbeat, ischaemic heart disease, myocardial infarction, pulmonary embolism.
 - chronic obstructive lung disease
 - kidney failure
 - cancer
 - brain haemorrhage or aneurysm, or
 - anxiety, stress or any mental disorderunless you call our freephone helpline on 0800 652 1018 and your cover is confirmed to you in writing or they give you a "screening reference number".
2. If you have consulted a doctor or received inpatient treatment in the last 12 months for any other ongoing medical condition, unless your doctor confirms you are fit to complete the trip you have planned.
3. If you have a terminal illness.
4. If you are travelling to get medical treatment abroad.
5. If you are expecting to give birth before you arrive home or within eight weeks of arriving home.
6. If you cancel your holiday to go into hospital as an inpatient or day patient, if you were on a waiting list for that inpatient or day patient treatment when this insurance was issued.
7. If you have previously been refused travel insurance.
8. If you have not lived in the UK for a continuous period of at least the last 12 months before you take out this insurance and are not registered with a UK doctor
